Sub: Sanction of works under Central Road Fund (CRF) Scheme - reg.

Sir,

I am directed to refer to the Ministry's circular issued vide letter of even no. dated 30.06.2010/05.07.2010 on the subject mentioned above, stipulating that the procedure for invitation of tender and award of works stipulated vide this Ministry's letter no. RW/NH-24035/4/2008-P&M/PIC dated 27.11.2009 and subsequent modification dated 21.05.2010 shall be followed in respect of the works sanctioned under CRF schemes which have not been awarded before 27.11.2009 and Ministry's Standard Bidding Document (SBD) shall also be followed for all such works costing ₹ 5 crore and above with effect from 1st April 2010 and until further orders.

2. In this regard kind attention is also invited to the Ministry's circular issued vide letter of even no. dated 29.11.2010, withdrawing the instructions given vide the letter of even no. dated 25.03.2010 (inter-alia stipulating that the Central Government would accord Technical, Financial Sanction and Administrative Approval for CRF works) with immediate effect.

3. In view of the above, the stipulations issued vide the Ministry's circular issued vide letter of even no. dated 30.06.2010/05.07.2010 on the above subject stands withdrawn with immediate effect.

4. This issues with the approval of Secretary (RT&H).

5. It is requested that the contents of this letter may be brought to the notice of all concerned for needful compliance.
