Ministry has decided to host all tenders of National Highways works/Centrally Sponsored Works through e-procurement. Further, it is appreciable to note that to maintain uniformity almost all the states have started following the e-procurement on NHAI/Ministry portal.

Based on subsequent development in NHAI and Ministry, it has been decided to appoint C1 India Pvt Ltd. Noida (UP) as service provider for providing e-platform for hosting tenders related to National Highways/Centrally Sponsored Works because it has been found more economical and safer than the existing one.

Thus, in order to maintain uniformity as earlier, it is desired that all the State/UT Government should use Ministry/NHAI portal being hosted by C1 India Pvt Ltd. Noida (UP) for e-procurement of all types of National Highways and Centrally Sponsored Works from 1<sup>st</sup> June, 2014. This shall be followed strictly.
