## Sir,

The following partial amendments are made in guidelines issued on the above mentioned subject vide letters of even number, dated 31.03.2016 and 22.08.2016, with immediate effect:-

(i) Para 3 (B) of letter dated 31.03.2016: - In case of differences in recommendations of the Screening Committee with the recommendations of the State level Evaluation Committee for Works with sanctioned cost of civil works more than Rs. 100 crores and up to Rs. 300 crores, the Competent Authority in the Ministry to accept bids based on the recommendations of the Screening Committee will be the concerned ADG / DG(RD) & SS as per the extant orders of Work Allocations issued from time to time.

(ii) Para 3 (C) of letter dated 31.03.2016: - The competent authority in the Ministry to accept the bids based on the recommendations of Evaluation Committee for the works with sanctioned cost of civil works more than Rs. 300 crores and upto Rs 500 crore will be the concerned ADG / DG(RD) & SS as per the extant orders of Work Allocations issued from time to time.

2. All other conditions stipulated vide letters of even number, dated 31.03.2016 and 22.08.2016 shall remain unchanged.

3. This issues with the approval of Competent Authority.

4. It is requested to bring the contents of this letter into notice of all concerned for needful compliance.
