In suppression to above mentioned RFP document issued on 22.10.2020, please find enclosed herewith a modified RFP (part I & II) of PMC in respect of National Highways and centrally sponsored road works proposed to be implemented on EPC Mode of Contract.

2. Initially, PMC shall be implemented on EPC projects having Total Project Cost (TPC) upto Rs. 1000 Cr for next one year, in respect of National Highways and centrally sponsored road works. PMC may also be engaged in Standalone projects such as Tunnels and Bridges having Total Project Cost (TPC) more than Rs. 1000 Cr during this year.

3. The feedback on implementation of the PMC document may be sent to the Ministry for further review of the documents. After one year document will be reviewed based on the experience & feedback.
