Subject: Strict compliance with the Procedure laid down for inviting tenders/quotations, appointments of Tender Committee and award of contract/supply order.

Some instances have come to the notice of this Department, where contracts for work/s have been awarded by certain organisations under the administrative control of this Department without inviting tenders/quotations or without following the prescribed procedure for appointing a Tender Committee, etc. This is not a satisfactory position. It is, therefore, impressed upon all the concerned authorities to ensure strict compliance with the procedure laid down for inviting tenders/quotations appointment of Tender Committee and award of contract/supply order, and also to have, at the same time, due regard to the Prime Minister's directive that performance should have precedence over procedures.

Subject: Guidelines regarding procedure to be adopted for the pre-qualification of tenderers for the execution of major road and bridge works on National Highways and under other Centrally Financed Schemes — Implementation thereof deferred till 1.4.1987.

Your kind attention is invited to the correspondence regarding the subject cited above resting with

this Ministry's circular letters Nos. RW/NHIII/P/4/82 dated 16.9.1985, 5.3.1986 and 18.3.1986. The above mentioned guidelines are being modified in the light of the experience gained while carrying out prequalification of tenderers for the execution of World Bank aided Projects.

2. Further, one of the Chief Engineers (National Highways) of a State PWD has brought to our notice that our latest decision (conveyed in our letter of even number dated 5.3.1986) that pre-qualification will have to be done for all road/bridge projects costing more than Rs 50 lakhs has created some difficulty for fixing up agencies for the execution of works during the financial year 1986-87 because the process of pre-qualification is quite elaborate and time-consuming and has to be done for each work costing more than Rs 50 lakhs separately. After examining all the pros and cons, it has been decided that the implementation of the procedures outlined in the above-mentioned circular letters of the Ministry may be *deferred to 1.4.1987 so far as works costing betwen Rs 50 lakhs and Rs 100 lakhs are concerned*. It may he clarified that the procedure of pre-qualification will have to be followed so far as the works costing more than Rs 100 lakhs are concerned.

Subject: Preparation of designs and working drawings by the State PWDs for bridges on National Highways and other Centrally Financed Schemes

Your kind attention is invited to this Ministry's Circular letter No. RW/NHVI-50(3)/83-NH Std. dated 15.7.85 wherein it was reiterated that for bridges of overall length not more than 125 m (or individual span length of 25 m or less) lumpsum tenders based on alternative designs should not be invited. Accordingly, the State PWDs were required to furnish detailed design calculations alongwith detailed working drawings for various components alongwith the original estimates relating to construction/reconstruction of bridges on National Highways and under other Centrally Financed Schemes. Even though the above mentioned instructions were issued in July, 1981 compliance of the same in a tangible manner is still awaited. It will be appreciated if immediate steps are taken at your end to ensure that the guidelines mentioned above are followed meticulously.

2. It has also heen brought to our notice that some of the State PWDs have got full-fiedged Design Organisations. It is felt that for such PWDs there should be no difficulty in the preparation of designs and working drawings for all bridge projects (irrespective of the overall length of the bridge or its span length) and in such States tenders for bridge works could be called only on the basis of Departmental Designs. This procedure will obviate the difficulties now being experienced by various State PWDs as well as this Ministry in conveying expenditure approval of detailed working drawings for different components of bridges which are got constructed on the basis of alternative designs of contractors, as all designs would be finalised at the time of sanctioning of estimates.

3. It will be only in case of very major bridges where the design will need to be got approved from the Ministry in case the tenders have been limited hy the State PWDs based on contractors our alternative designs (on lumpsum basis).

4. It is requested that suitable instructions may kindly be conveyed to all concerned for complying with the procedure given in the preceding paragraphs.
