Subject: Rates of Hire Charges of New Machinery procured during the years 1987-89.— Regarding.

Ministry vide letter No. RW-RM-26(1)/84 dated 7.11.84 had communicated the revised rates of hire charges of Central Machinery. After that Ministry have procured some more machinery during the years 1987-89. The rates of hire charges of these new machinery procured have been calculated and are enclosed at Appendix 'A' for adoption with immediate effect. The rates calculated include ownership charges, operational charges and overhead charges per hour/km. as the case may be. These do not include running charges which are likely to vary from State to State with different Pay scales of Staff, and due to prevailing rates of fuels and lubricants. The running charges may therefore be worked out by the State P.W.Ds as per the guidelines communicated vide Ministry's letter No. 21(3)/75 dated 4.6.1976 and included while calculating the total hire charges for being incorporated in NIT and work estimates, wherever applicable.

2. There is no change in the procedure for accounting of hire charges of Central machines as already intimated in Ministry's letter Nos. RM-21(3)/75 dated 4.6.76, 1-10-1977 and 2.5.78. However, there is change in Head of account and the hire charge components for both departmental and contractor use may be credited to the new head of account as indicated below:

Ownership charges to be credited to "Major Head 5054-AA-Capital outlay on Roads and Bridges - AA. 1-National Highways-AA.1(1)(2)-Machinery and Equipment".

Operational and overhead charges are to be credited to "Major Head 1054-Roads and Bridges-other receipts".

3. This supercedes the interim instructions issued to CE(NH)S Bihar/UP/Gujarat vide letter of even numbers dated 22.4.88, 12.10.88 and 26.10.88.

4. The above instructions may kindly be brought to the notice of all concerned in their department under intimation to the Ministry.
