Subject : Usage charges of plant and Machinery to be used on National Highways

The usage charges of Plant and Machinery were incorporated in the Chapter 10 of Standard Data Book of the Ministry of Surface Transport published by IRC in 1994, the revision of which was under consideration in the Ministry due to increase in cost of machines and plant, wages of staff, POL charges, etc. These have now been finalised, as shown in *Appendix*. It has been decided that the usage charges of plant and machinery shown in *Appendix* may be adopted for inclusion in works estimate, in future.

2. The calculations have been made following Ministry's guidelines contained in letter No. RW21(3)/75 dated 4th June, 1976, RW24011/1/88-RMP dated 5th May, 1988 and RW-24011/5/93-RMP dated 30th December, 1998.

3. These usage charges of plant and Machinery includes hire charges, operational, servicing and running charges component, and are applicable to Department and Contractor separately.

4. In case Department machines are available with the State Govt., the operational rates should be incorporated in works estimate and ensured that Ministry's machines are fully utilised. It may also be ensured that similar type of machine, for which provisions have been made in the works estimate are deployed on that specific job.

It has got the approval of Director General (Road Development) & Addl. Secretary.
