

Sub:- Permanent Solution to Slip Zones on Papu-Yupia-Hoj-Potin section of NH-713A & NH-13 location at Km 31.00 (Hoj Market), KM 38.300 (Yabi village), Km 39.00 (Waterfall), Km 39.700 and Km 40.300 in the state of Arunachal Pradesh on EPC mode- **Partial modification in Suspension Notice issuance - regarding.**

Dear Sir,

In partial modification of Suspension order issued vide letter No. CEAP (HW)/W-4/P-Y-H-P/2024-25/1541-45 dated 02.08.2024 a modified order is being issued herewith:-

In reference to the Minutes of the meeting issued vide No.CEAP(HW)/W-4/P-Y-H-P/2023-24/1535-39 dated 02.08.2024, whereas, it is evident that you had made some drastic changes to the Agreement drawings vetted by THDC in the form of modified design & drawings based on your field investigation reports duly vetted by the approved Design Director, Proof Consultant and Safety Consultant. This had the scope pf work drastically reduced in the construction design stage itself.


Whereas, based on the modified design & drawings submitted, you had executed the restoration measures with the reduced/altered scope of work. For example, at location Hoj Market - Km 31.00:- The RE Wall height was drastically compromised by changing the foundation level; At Yabi village - instead of RME barrier, a single RME structure was constructed; At waterfall - 39.00 Km location, the down slope stabilization was totally ignored alongwith different length and spacing of SDRA; Drastic reduction in height of RE wall and Reinforced Soil Wall at 39.700 KM and Crusher Point 40.30 Km respectively.

Whereas, the RE wall of length - 10.40 mtr at Hoj Market (31.00 Km) had collapsed. Also, the RME structure built had already bulged and hence failed. In addition, the reduced scope of work already constructed or under construction at location Waterfall - 39.00 Km, 39.700 Km and crusher point 40.300 Km has raised the question of stability of the built restoration measures, thereby risking the safety of the road users.

Furthermore, as per Clause 11.13(b) & (c) of the CA, you are hereby instructed to remove and re-execute any work not done in accordance with the provisions of the Agreement and Specification and Standards and also execute any work which is urgently required for the safety of the Project Highway.

In light of the above factual findings and as per Ministry Circular dated 06.10.2021 Para 5, you are hereby temporarily suspended for a period of 1 (one) month from participating in ongoing/future bidding w.e.f. issue of this notice.
