Ministry vide circular reference (i) above has issued detailed guidelines regarding Skill Development of Workmen in Highway Construction Sector consisting details of Obligation of the Authority, Trainings, Assessments & Certifications for National Highway Projects.

2. Further Ministry vide circular mentioned under reference (ii) has issued some modifications including the list of trades for training, selection of Training Providers (TPs), Assessing Bodies (ABs), size of batches in one training program, fee of assessor etc.
3. In this regard, it has been learnt from various field offices that they are facing difficulty in allocating the work for Skill Development to various empaneled Training Partners (TPs).

4. The above matter has been reviewed by the Ministry and following is clarified:

- (i) Allocation of Skill Development of Workmen in Highway Sector shall be done by the respective Regional Officers (MoRT&H, NHAI, NHIDCL). The Nodal Officers shall maintain and furnish the list of project sites costing **Rs.200 Crores and above** where training infrastructure has to be set up by the Training Providers.
- (ii) The concerned Regional Officer of MoRT&H/NHAI/NHIDCL shall allocate the projects to the TPs on the basis of first come first serve basis. However, maximum number of projects to particular TPs shall not be more than 25 percent of the eligible projects under their jurisdiction.
- (iii) The CSDCI shall be contacted for assigning the task of conducting Assessment through empaneled Assessing Bodies (ABs).
- (iv) While selecting the project and allocating the training, concerned Regional Officer/Project Director/Executive Engineer shall ensure that the Training is completed before completion of the Civil Work. As a General Guideline, projects where the physical progress is in between 20% to 60% may be allowed for conducting Training Program.
- (v) The TPs shall be allocated by Concerned Regional Officers amongst the empaneled list by CSDCI/NSDC. The Regional Officers/Project Directors/Executive Engineers shall be responsible for implementing the training through empaneled/authorized Training Providers (TPs) by Construction Skill Development Council of India (CSDCI)/ National Skill Development Corporation (NSDC).
- (vi) The list of TPs and ABs of CSDCI/NSDC may be obtained from the website that is **[www.csdcindia.org](http://www.csdcindia.org), [www.nsdcindia.org](http://www.nsdcindia.org)**.
- (vii) The Regional Officers shall furnish the progress report on monthly basis to the Skill Development Cell of the MoRT&H.
- (viii) The expenditure shall be incurred by the concerned Regional Officers/Project Directors as per the existing guidelines mentioned under reference.
