**Subject: Skill Development of Workmen in the Highways Construction Sector regarding.**

**Ref:** Ministry's circular no. RW/NH-11065/2/2017-P&M (Mon) dated 02.08.2019.

Madam/Sir,

Ministry vide referred circular has issued guidelines regarding the Skill Development of Workmen in the Highways Construction Sector. The skill development programme was discontinued during COVID-19 pandemic. It has now been decided to re-start skill development programme from the year 2023-24 in National Highways projects with civil construction cost of Rs. 200 crore and above.

2. The skill development programme shall be conducted in accordance with Ministry's circular under reference with following modifications:

2.1 Number of participants in one training programme shall be between 25 and 35.

2.2 Following training programmes may be conducted depending on local demand and availability of workmen. The course duration and amount to be paid to training provider per hour are indicated therein:

2.3 Assessor will be paid assessment fee of Rs. 1200 per candidate.


