Subject:-Collection and re-use of waste plastic : Swachhata hi Seva Campaign.

Government has decided that in 2019-20 the "Swachhata hi Seva Campaign (SHS)"

will focus on Plastic Waste Management as main theme. The campaign will run as per the following timeline:-

11 th September -1 st October	Preparation and awareness generation
2 nd October	Nationwide shramdaan and national pledge
3 rd October -27 th October	Recycling and effective disposal of collected plastic waste

2. In this regard, following instructions are issued for collection and re-use of the waste plastic:-

- (i) All Regional Officers of Ministry/NHAI/NHIDCL may co-ordinate with all States and Union Territories to receive plastic waste collected at various centre to be used for road construction.
- (ii) The plastic waste is to be used as per the Guidelines issued by the Ministry and IRC SP:98-2013 'Guidelines on the use of waste plastic on Hot Bituminous Mixes (Dry process) in wearing courses' for road construction, beginning with the exercise to be undertaken post 2nd October.
- (iii) From 11th September (launch of SHS 2019) to 1st October, all Regional Officers of Ministry/NHAI/NHIDCL may make provisions for plastic waste to be collected at designated centres along with the required mechanisms for containment.
- (iv) On 2nd October, all highways personnel may undertake Shramdaan and ensure the collection of all plastic waste on and around National Highways.
- (v) From 3rd October onwards, all plastic waste collected may be used for road construction, as cited above.
- (vi) All collected waste may be recycled by 27th October, 2019 (Diwali).
- (vii) The effort should be supported with an awareness generation campaign, specially at toll plazas.

3. All Regional Officers of Ministry/NHAI/NHIDCL will prepare an Action Plan for the activities mentioned above and submit the same by 30th August, 2019 to the Nodal Officers for preparing the consolidated Action Plan.
