Preparation of Schedule of Rate based on Ministry's Standard Data Book for Rate Analysis (1994)

Please refer to Ministry letter No. RW/NH-33045/4/92 - S&R dated 23rd May, 1994 wherein State PWDs where requested to prepare Schedule of Rates (SOR) for National Highways and other Central Sector Work's on the basis of Ministry's Standard Data Book for Rate Analysis. It was also requested, that the Schedule of Rates would be periodically updated for preparation of the detailed estimates to arrive at a realistic cost of work. In this regard the D.O. letter No.RW/NH-33049/6/98-S&R dated 15th April, 1999, from DG (RD) & AS addressed to all the Chief Engineers of States/Union Territory, may also please be referred to wherein it was categorically mentioned that in future no estimate will be accorded approval by the Ministry, unless the estimate is in accordance to the Schedule of Rate based on Ministry's Standard Data Book for Rate Analysis.

2. However, inspite of Ministry's constant pursuit it is noted with concern that a number of State have not even prepared the Schedule of Rate for National Highways and other Central Sector Works, leading to unrealistic cost estimate which is largely responsible for revised cost estimates in most of the projects. This has been viewed seriously in the Ministry at the highest level, and it has been decided that all such States, which had not yet framed SOR for NMs work, should prepare SOR based on Ministry's Standard Data Book for Rate Analysis latest by 30th September, 2001. The States, Which have already prepared SOR as per Ministry's Standard Data Book, may please confirm that the same has been updated to the current prices.
