Sub:- Installation of Cautionary Sign Boards on potential landslide locations on all National Highway Network- reg.

Sir,

Ministry has taken serious note of the fact that there have been many landslide susceptible locations on the National Highway network. These landslides pose serious threat to safety of the road user besides causing loss to road assets and adjoining property. These locations can easily be identified during operation and maintenance activities on NH's but the executing agencies are not taking any concrete steps to effectively monitor the landslide susceptible locations and forewarn the road user safeguarding the loss of human lives and road assets.

2. Henceforth, it has been decided that all such locations may be identified on all the National Highways within your jurisdiction and cautionary sign boards (in conformity to latest IRC:67, Code of Practice for Road Signs) shall be installed immediately forewarning the commuters. Any expenditure on this account may be met out of funds allocated for Ordinary Repairs/maintenance funds. A compliance report in the enclosed proforma (Annexure) may please be furnished within a fortnight.
