# Subject:-Department related Parliamentary Standing Committee on Transport, Tourism and Culture- Action Taken Replies on recommendations /observations contained (Para 92 of the 317<sup>th</sup> Report) -Necessary Direction/advisory to tackle the problem of stray cattle and other animals trespassing National Highways.

#### Madam/Sir,

The Department related Parliamentary Standing Committee on Transport, Tourism and Culture recommends that "urgent steps may be taken in coordination with concerned local authorities to tackle the problem of stray cattle and other animals trespassing National Highways posing tremendous security risk to the passengers, especially women, seniors and children, besides causing hindrance on the smooth flow of traffic on NHs.
