## Madam/Sir,

The Parliamentary Standing Committee on Transport, Tourism and Culture has taken note of the various measures taken by the Ministry for rectification of black spots and recommends that a mechanism may be put in place to ensure the periodical monitoring and maintenance measures such as regular trimming of the shrubs and trees on the Highways so that the signages installed on the Highways remain clearly visible to the drivers at all seasons.

2. Ministry has issued standard EPC document on 05.03.2019 which specifies the maintenance obligation of the contractor. The Schedule - E of this EPC document obligates the contractor to ensure at all times during the maintenance period, the project highways conforms to the maintenance requirement set forth in this Schedule.

Further as per Table 3, maintenance criteria for safety related items and other furniture items, obstruction due to trees and plants including median plantation shall be removed immediately conforming to IRC SP: 84-2014.
