Delegation of Powers to Technical Officers/Level jumping

It has been brought to the notice of Director General (Road Dev.) & Addl. Secretary that this Ministry's order of even number dated 16.5.2000 regarding enhanced delegation of powers to the Technical Officers posted at Headquarters to accord technical approval in the name of D.G.(RD) & A.S. to the detailed estimates in respect of NH original works and SR/FDR Road and Bridge work has created some confusion amongst Officers at the level of Executive Engineer and below regarding their duties. The duties of technical officers in respect of the technical work in Project Zones have, therefore, been detailed in the enclosed statement for guidance.

It is once again clarified that technical officers working in zonc will be required to carry out any work assigned to them by the zonal head, i.e., Chief Engineer though the same may not be covered by the enclosed detailed duties. More specifically, if an Executive Engineer is not in position then the concerned AEE will be expected to discharge the functions indicated in addition to his own duties. Similarly, if a Superintending Engineer is not in position, the concerned Executive Engineer will handle the dutics mentioned in these circulars in respect of S.Es. in addition to his own duties but the approving authority in the absence of S.Es. in a zone will be the next higher officer.

In general, in the absence of competent approving authority as per enclosure; the proposal shall be got approved by next higher officer.
