I am directed to say that vide circular no. 11014/7/2013-P&M, dated the 14th August 2013, this Ministry has made provision for supervision charges and other charges in the form of centages in estimates/technical proposals for NH projects to be executed in EPC mode.

2. Consequent upon the withdrawal of umbrella State-wise appointment of Authority Engineer and the decision to appoint Authority Engineer on project wise basis vide Circular No. RW-NH-34048/7/2013-S&R(B) dated 1^{st} January, 2016, the amount available as supervision charges under centage provision in the sanctioned estimate for a particular project shall be used for the payment of Authority Engineer for that particular project. If at any stage the amount payable to the Authority Engineer exceeds this ceiling amount, the revised supervision charges shall be first got approved from the Ministry.

3. The delegation of powers for invitation, evaluation and acceptance of bidsfor selection of Authority Engineer for different category of projects shall be as under.

The above delegation shall apply if the financial component of the bid consider $c_{1,2}$ acceptance is within the ceiling amount available as supervision charges for the project $c_{2,2}$ centage provision. For all other cases, specific sanction of the Ministry shall be obtained to acceptance of bids.

5. Bids shall be invited following laid down policy for e-procurement using Ministry's prescribed e-tendering platform. The Standard RFP document shall be used unless otherwise approved by the Ministry.
