**Subject:-** Delegation of powers of Highway Administration of the powers conferred by the Control of National Highway (Land & Traffic) Act, 2002


In exercise of the powers conferred by rule 3(1) of the Highway Administration Rules, 2004, the Highway Administration hereby authorizes, the Regional Officers of this Ministry to exercise the powers and discharge the functions conferred on it by the Control of National Highways (Land and Traffic) Act, 2002 (13 of 2003) except those under sections 24, 25, 26, 27 and 43 thereof, in respect of the limits of the National Highways as specified in the corresponding column (3) of the table given hereunder.
