2 In the view of above, as per Clause 3.4, (x) (a) of Section 2 of the RFP and as per the guidelines issued by Ministry vide letter no. RW/NH-33044/24/2020-S&R (P&B) dated 06.01.2021, the proposed Team Leader cum Senior Bridge Engineer - Sh Shailesh Kumar Tiwari is being debarred for a period of 2 years from future projects of Ministry and its executing agencies.
