It is brought to the notice of all that Mr. Javed Khan was selected as Resident cum Highway Engineer by, M/s AECOM Asia Company Limited JV with M/s G Eng Advisory Services Private Limited in association with M/s Shree Bhawani Consultancy Service Pvt. Ltd. for the work of "Consultancy Services for Authority's Engineer for Supervision of "4-Laning of Itanagar to Banderdewa section of NH-415 from km 40+430 to km 51+735 (Package-B) and Km 51+700 to Km 59+199 (Package-C) on EPC Mode in the state of Arunachal Pradesh"".

2. The Authority's Engineer vide letter no. AECOM/AP/Ita-Band/NH-415/2023/875 dated 01.06.2023 has informed that Mr. Javed Khan has refused to join the assignment in spite of giving consent for the said project on 05.05.2023 and approval accorded by the Authority vide letter no. 415/Ar.P/2020-21/031/AE/RO-Ita/12050-52 dated 31.05.2023.

3. Therefore, as per stipulation of the GCC Clause 4.5.6 of Contract Agreement Mr. Javed Khan is hereby debarred/blacklisted from participating in future projects of MoRTH/NHIDCL/NHAI for a period of 2 years from the date of issue this notice.
