Sir,

In pursuance to the order dated 13.01.2016 of Hon'ble Delhi High Court, the undersigned is directed to refer to this Ministry's letter cited under reference wherein you have been debarred for participating in any future consultancy works related to NHs and other centrally sponsored schemes for a period of one year and to say that the said letter is hereby withdrawn with the approval of the competent authority.

2. As per the directions of the Hon'ble High Court, a fresh show cause notice is being given to you. In the meanwhile, in case you participate in any tender related to MORTH, you shall specifically disclose that you were debarred by the department and the said order was withdrawn by the department as per the order of the Hon'ble High Court and in pursuance to directions of the Hon'ble High Court, a fresh show cause notice has been issued and received by you/ is proposed to be issued/is pending against you. You will also indicate that as per the order of the Court, if your firm is subsequently debarred, then tender submitted by your firm shall be considered as non-responsive.

3. This issues with the approval of Competent Authority in the Ministry.
