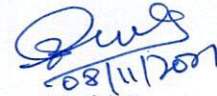

**Office Memorandum**

M/s Hexa Co. in association with L.N. MalviyaInfra Projects Group Pvt. Ltd, had informed that Mr. Abolghasem Parpinchi (DOB 21.03.1963, PAN ABCDE7829H, E-mail: [mailtoparpinchi@gmail.com](mailto:mailtoparpinchi@gmail.com)) could not continue his assignment for the position of Team Leader cum Senior Tunnel Engineer for "Project Management Consultancy Services for Construction of Highway 2-Lane Tunnel including approaches across the Mussoorie Hills (Design Chainagekm 0.700 of Cart-Maccanzi Road to km 156.700 of Tyuni-Chakrata-Mussoorie-Dhanolty-New Tehri Road of NH-707A) in the State of Uttarakhand".

The reason for discontinuation of services of key Personnel (Team Leader cum Senior Tunnel Engineer) of the approved team of the Consultant Mr. Abolghasem Parpinchi submitted by the Consultant does not seem justified keeping in view the facts and requirement of the work. Further the discontinuation of services of Mr. Abolghasem Parpinchi entitles the Client to invoke declaration submitted in certificate in Form-T10 by Mr. Abolghasem Parpinchi that *"if he leaves this assignment in the middle of the work, Employer would be at liberty to debar me from taking any assignment in any of the Employer works for an appropriate period of time to be decided by the Employer"*.

Hence, the Competent Authority in the Ministry has decided to debar Mr. Abolghasem Parpinchi for a period of 24 months from being engaged as a team member of any consultant working (or to be appointed) for any other MoRTH projects as per Clause 4.5.6 of Contract Agreement, from date of this O.M.
