**Subject: Debarment of Mr. Anis Ahmad Khan for a period of two years for all projects of MoRTH.**

It is brought to the notice of all that Mr. Anis Ahmad Khan was appointment as Team Leader cum Sr. Highway Engineer by M/s AICONS Engineering Pvt. Ltd. for the DPR work of "Consultancy Services for preparation of DPR of 2-laning of the proposed Frontier Highway from Nafra to Vijaynagar in the State of Arunachal Pradesh (Package-8)".

2. DPR Consultant vide letter no. AICONS/DPR/Arunachal Pradesh/Pkg-8/2020-21/1095 dated 18.11.2021 has stated that the health condition of Mr. Anis Ahmad Khan, Team Leader is not good and is unable to continue as Team Leader for the DPR work. Consultant vide letter no. AICONS/DPR/Arunachal Pradesh/Pkg-8/2020-21/1223 dated 19.01.2022 has stated that Mr. Anis Ahmed Khan, Team Leader worked on the DPR since start upto 30.09.2021. However, he had not attended any of the site inspection, meetings or interacted with the Authority, which makes it evident that he remained absent for the DPR work.

3. In view of the above, the Competent Authority in the Ministry has decided to debar Mr. Anis Ahmad Khan for a period of Two years from being engaged as a team member of any other consultant working (or to be appointed) for any other MoRTH projects as per the stipulation in Clause 3.2.4 (vi) of LOI and Clause 4.5.6 of the GCC of the Contract Agreement, from date of this O.M.
