**Subject:** Debarment of Mr. Sandeep Jaiswal for a period of two years for all projects of MoRTH. - **Reg.**

It is brought to the notice of all that Mr. Sandeep Jaiswal (Email: ersandeep57@yahoo.com) was appointed as Team Leader cum Senior Highway Engineer by the DPR Consultant, M/s Manglam Associates in JV with M/s Oms Infra Consultants Pvt. Ltd. for the DPR work of "Consultancy Services for preparation of DPR of 2-laning of the proposed Frontier Highway from Nafra to Vijaynagar in the state of Arunachal Pradesh in 9 Packages (Package-2: Lada to Sarli, 200 Km)".

2. DPR Consultant vide letter No. OMS/HO/BD/MORTH/2021-22/40 dated 28.01.2022 proposed for replacement of Shri Sandeep Jaiswal stating that he is unable to attend the site regularly because of his health issues. However, the basis of health issue and documentary evidence were not furnished despite request and reminder issued by the Authority on 10.02.2022 and 21.02.2022.

3. As per Clause 3.2.4 (vi) of LOI, *...in case of non-availability of key personnel in spite of his/her declaration, he/she shall be debarred for a period of two years for all projects of MoRTH.*

4. In view of the above, with the approval of Competent Authority in the Ministry, Mr. Sandeep Jaiswal (Email: ersandeep57@yahoo.com) is debarred for a period of two years from being engaged in any project of MoRTH as per Clause 3.2.4 (vi) of LOI of Contract Agreement w.e.f. the date of this O.M.
