The default/deficiency on the part of AaroHi Travels Solution as notified vide this office letter no. RW/RJ/JAI/ESTT(45)/98/240/429 dated 12.05.2022 is on account of following:

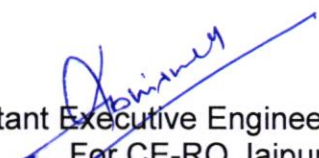
1.1 Signing of Agreement: The client will sign Agreement with the selected bidder to whom the LOA has been issued within 7 working days from the LOA. Hence the agreement was required to be signed by 20.04.2022. Authorized representative from AaroHi Travels Solution did not turned up for signing the agreement.

1.2 As per RFP, the vehicle should not be more than one year old on the date of NIT and should not have run more than 20000 km. The same has not been provided by your firm.

2. Accordingly this office vide letter no. RW/RJ/JAI/ESTT(45)/98/240/429 dated 12.05.2022 requested AaroHi Travels Solution to explain within 5 day from the issuance of Show Cause Notice as to why necessary action not be taken to debar AaroHi Travels Solution and other firms whose owner/entrepreneur/director is Shri Mahesh Kumar Meena from participating in tenders for 2 years in MoRTH and other organizations. No reply of Show Cause Notice dated 12.05.2022 has been received from AaroHi Travels Solution till now.

3. Hence LOA issued vide letter no. RW/RJ/JAI/ESTT(45)/98 /152-153 dated 13.04.2022 stands cancelled.

4. Further AaroHi Travels Solution and other firms whose owner/entrepreneur/director is Shri Mahesh Kumar Meena is debarred from participating in tenders for 2 years in MoRTH and other organizations from the date of issue of this letter.
