Subject:- Appointment of Private Medical Practitioner as Authorized Medical Attendant (AMA).

Sir,
I am directed to refer to your letter dated 07.08.2021 on the above mentioned subject wherein you have conveyed your willingness for being appointed as Authorized Medical Attendant and to say that it has been decided to appoint you as AMA for the officials of this Ministry and their family members residing at Faridabad and within 8 kms. radius for a period from 11.08.2021 to 31.03.2022 on the terms and conditions reproduced below :-

- i. The appointment would be for a period from 11.08.2021 to 31.03.2022 as shown above or the Ministry reserves the right to terminate the appointment any time without assigning any reasons or giving any notice.
 - ii. You will charge fee for consultation and injections at rates prescribed by Ministry of Health & Family Welfare, and
 - iii. You will follow strictly the provisions of Central Services (Medical Attendance) Rules, 1944 and orders issued thereunder from time to time.
 - iv. As per Govt. of India decision (3) under Rule 6 of CS(MA) Rules, 1944, the AMAs, those who are having their own or attached to private hospitals/nursing homes should not refer the Central Govt. Employees and member of the families to Private hospitals/nursing homes. In case the hospitalization treatment becomes essential, the AMAs should invariably refer cases to the Govt. hospitals or hospitals recognized under CS(MA) Rules, 1994 and as per OM No.S-14025/01/2014-MS dt 05.03.2014.
 - v. As per O.M.No.S-14025/41/2015-MS dt. 07.12.2016 Medical facilities, which also include dental treatment, can be availed by CS(MS) Beneficiaries in any Private hospital recognized under CGHS/CS(MA) rules, 1944 and the hospitals recognized by the State Government on the recommendation of their concerned AMA and after obtaining permission from their respective Deptt./Ministry.
