- 3) The recommendations of above mentioned conciliation committee shall be approved by Hon'ble Minister of State (RT&H) handling the Roads Wing, after concurrence of IFD and approval of Secretary (RT&H).
- 4) Disputes of more than Rs. 5 cr. shall continue to be referred to the pre-Conciliation Committee as per Ministry's OM dated 28.12.2023.
- 5) This issues with the approval of Competent Authority.
