## Invitation of public comments

Subject:-Permission Proposal for Erection overhead construction of + 800KV Raigarh - Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) of NH-48 in the State of Tamil Nadu-Reg.

The proposal is regarding permission Proposal for Erection overhead construction of + 800KV Raigarh - Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) of NH-48 in the State of Tamil Nadu was submitted to this office by the PD, NHAI, Krishnagiri vide letter No.11013/EB Crossing/2019/PIU-K'giri/1201 dated 16.07.2019 has submitted the proposal to this office in accordance with Ministry's latest guidelines dated 22.11.2016.

- The alignment proposed by M/s Power grid Corporation of India Ltd., Pugalur submitted the proposal for Erection overhead construction of + 800KV Raigarh Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) of NH-48 in the State of Tamil Nadu. The license (Power grid Corporation of India Limited) has submitted and agreement regarding granting of right of way for overhead construction of + 800Kv Raigarh-Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) of NH-48 and undertaking to comply with standard condition of Morth guidelines i.e. in a span of 400 Mtr.(NH crossing length 76m as per drawing submitted)
- 3. The right of way + 800KV Raigarh Pugalur HVDC Transmission line Transmission system -Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) the aforesaid stretch. M/s Power grid Corporation of India Ltd., Thogarapalli has proposed to Erection overhead construction of + 800KV Raigarh-Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m). However, out of the aforesaid length, + 800KV Raigarh - Pugalur HVDC Transmission line Transmission system - Crossing line at 33/045 in Bandarapalli Village, on Krishnagiri (Vertical clearance of ground to line is 27.50m) in line crossing normally to road for a length of 50m of NH, ROW. Further, Power grid Corporation of India Ltd., has mentioned that the D/C transmission line overhead 800KV line above the Right of Way will be 37.5m above the carriageway.
- M/s Power grid Corporation of India Ltd., Pugalur has furnished an undertaking to the effect that M/s Power grid Corporation of India Ltd., Pugalur will remove the laid 400KV line in future if required by NH wing of State Highways Department/MoRTH Govt. of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that M/s Power grid Corporation of India Ltd., Pugalur will also maintenance thereof and against all claims, proceedings, damages, costs, charges and expenses whatsoever in respect thereof in relation there to restore the surfaces to its original condition soon after overhead construction of + 800Kv Raigarh. Also, certified that the proposed of ± 800Kv Raigarh line work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the relaxation application submitted by the applicant will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
