**Subject:**- Permission Proposal for laying underground 150mm dia PVC water pipeline for agriculture purpose along the National Highways from Km 284/870 to 286/650(LHS) of NH 948 (Sathyamangalam to Coimbatore Road) at S.F.No.89/2 at Annur Village, Avinashi Taluk, Coimbatore District in the State of Tamil Nadu- Reg.

The proposal is regarding request for permission for laying underground 150mm dia PVC water pipeline for agriculture purpose along the National Highways from Km 284/870 to 286/650(LHS) of NH 948 (Sathyamangalam to Coimbatore Road) at S.F.No.89/2 at Annur Village, Avinashi Taluk, Coimbatore District in the State of Tamil Nadu by Thiru. Govindaraju S/o Nallasamy Gouder, D.No.176, Sathy Main Road, Annur resubmitted to this office by the SE (NH), Salem vide letter No. 252/2020-21/JDO/dated 21.03.2022(received on 04.04.2022). The proposal has been examined and the details are as under:

- 2. The Right of Way in the stretch of NH proposed for laying underground 150mm dia PVC water pipeline is varies 25.20 to 38.20m. The carriageway width of stretch from Km 284/870 to 286/650(LHS) of NH 948 is 7.00m. Thiru. Govindaraju S/o Nallasamy Gouder, D. No. 176, Sathy Main Road, Annur has proposed to lay the underground 150mm dia PVC water pipeline at edge of the ROW for a length of 1780m by adopting open trench method along the National Highway.
- 3. Thiru. Govindaraju S/o Nallasamy Gouder, D.No. 176, Sathy Main Road, Annur has furnished an undertaking to the effect that they will remove the laid underground 150mm dia PVC water pipeline in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, Thiru. Govindaraju S/o Nallasamy Gouder, D.No. 176, Sathy Main Road, Annur will also restore the ROW surfaces to its original condition soon after removal of the underground 150mm dia PVC water pipeline. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
