Sub.: Proposal for final formal permission and signing of license deed for access to the proposed fuel station of M/s IOCL on NH -330 (Old NH No. 96) at Km. 126.339 (RHS), Village - Patupur, Tehsil - Bikapur & District Faizabad in the State of Uttar Pradesh - Time Extension - Reg.

- 1. The instant proposal was granted provisional NOC vide this office letter no. RO/LKO/HA/NH-330 (96)/99/2014/1698 dated 09.10.2014. As per para-3 of the same "In case the construction is not done in one year of the issue of this provisional NOC, the same shall be deemed to be cancelled, unless renewed by the Competent Authority." However, it is observed that the proposal has been submitted to this office after the lapse of stipulated deadline. Thus, it is seen that there is delay in construction of the instant retail outlet and involves deviation from the Ministry's extant guidelines.
- 2. The Oil Company M/s Indian Oil Corporation Ltd. has submitted justifications for the delay, wherein it is mentioned that:
- (i) NOC from DM was granted to Oil Company on 20.07.2018 i.e. around 3 years 9 months and 11 days after the provisional NOC was issued. Thus the Oil Company could not start the work immediately on the site in absence of these statutory approvals as budget is approved only when all the statutory approvals are in hand. Hence, it is resulted in delay of construction work of retail outlet. Construction work of the fuel station has been completed on 18.07.2019 i.e. within one year after the DM NOC was issued.
- 3. As per the guidelines, issued by the Ministry vide OM No.RW/NH-33023/19/99-DO.III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments will be invited within 60 days from the day of uploading as per the format enclosed as Form-A (Annexure-I).
- 4. In view of the above, comments of the public on the above relaxation proposal because of non-fulfillment of completion of the criteria of construction with in stipulated time-period, is invited to the below mentioned address:
