- Sub:- Four-Laning of Chutmalpur-Ganeshpur Section of NH-72A from Km.0.000 (Km.22.825 of NH-73) to Km.16.000 (Design Km.17.900) & Roorkee-Chutmalpur-Gagalheri section of NH-73 from Km.0.000 (Km.167.800 of NH-58) to Km.33.000 (Design Km.35.400) in the State of Uttarakhand & Uttar Pradesh under NHDP-IV on Hybrid Annuity Mode.
- S.H:-Proposal submitted by Wing Commander, PICG, AFNET Section, Air Force Station, Sarsawa, Saharanpur for Seeking Permission/NOC for laying of Optical Fibre Cable along the road from Km.11/000 to Km.11/400 (RHS) and from Km11/400 to 17/680 (LHS) of NH-73 & 1 Crossing at Km 11/400 of NH-73, for a total length of 6.68Km by trenchless (HDD) method-reg.

A proposal was received from Authorized Signatory of applicant i.e., Wing Commmander, PICG, AFNET Section, Air Force Station, Sarsawa, Saharanpur regarding laying of Optical Fiber Cable along the road from Km.11/000 to Km.11/400 (RHS) and from Km11/400 to 17/680 (LHS) of NH-73 & 1 Crossing at Km 11/400 of NH-73 for a total length of 6.68Km by trenchless (HDD) method-

- 3. The Optical Fiber Cable will be laid more than 1.65m below Ground Level as per the Ministry Sipulation of minimum 1.20m below the Ground Level.
- 4. Crossing Proposed by trenchless method with encasing OFC for the entire width of NH. The encasing pipe will be laid at 1.65m below the Ground Level as per the Ministry Stipulation of minimum 1.20 meter below the ground level.
- 5. As per MoRTH Guidelines no. RW/NH-33044/29/2015S&R(R) dated 22.11.2016, the Highway Administrator will make available the subject proposal for 30 days in the public domain for seeking public comments/objections (on the ground of public inconvenience, safety and general public interest).
