Invitation of Public Comments

Sub: <u>Access Permission to the proposed Retail Outlet M/s IOCL on LHS at Km.223.375</u> to Km.223.420 of NH-74 (New NH-09) in Village Chutki, Tehsil-Kichcha, <u>District-Udham Singh Nagar in the State of Uttarakhand.</u>

S.H:- Proposal for Issue of Extension of Time for in-principal approval/ Provisional NOC-Requested upto 30.09.2020-reg.

The proposal is regarding access permission for proposed retail outlet of M/s IOCL on LHS at Km.223.375 to Km.223.420 of NH-74 (New NH-09) in Village Chutki, Tehsil-Kichcha, District-Udham Singh Nagar in State of Uttarakhand.

2. Earlier, RO-Dehradun, MoRTH vide letter no. CE-RO/UK/NOC/RT/2017-18/15 dated 09.03.2018 had accorded "in-principal" approval for access permission for the proposed retail outlet of M/s IOCL on LHS at Km.223.375 to Km.223.420 of NH-74 (New NH-09) in Village Chutki, Tehsil-Kichcha, District-Udham Singh Nagar in State of Uttarakhand. Also therein it was mentioned that in case, the construction was not done in one year of the issue of provisional NOC, the provisional approval shall be deemed to be cancelled unless got renewed.

3. Subsequent to above, PD PIU-Rudrapur vide letter no. NHAI/PIU-RUPC/NOC/2020/519 dated 18.02.2020 submitted this proposal to this office. Upon examining the proposal, this office vide letter no. 50063/NHAI/RO-UKD/2014/12762 dated 04.03.2020 had sought certain clarification.

4. PD PIU-Rudrapur has submitted that the said matter was taken up with the concerned agency to submit the reasons/ justification for such delay & in response to which, M/s IOCL have submitted the detail justification for delay in construction informing that once inprincipal approval is solicited from RO-MoRT&H, several other permissions from district administration are also required to be solicited prior to start of construction of retail outlet, which were out of their hands and hence, the matter got delayed due to delay in such permissions. Hence, in view of this, since the matter got delayed due to delayed permission from district administration, therefore, M/s IOCL shall not suffer for such delay & hence the clarifications submitted by M/s IOCL is acceptable & the instant case is recommended to solicit approval for extension of time upto 30.09.2020 to M/s IOCL.

As per Ministry's letter No. RW-NH-33023/19/99-DO-III dated 01.12.2014 "the highway administration may grant one-time extension upto one year for the period of construction, on genuine grounds and with proper justification(s) for the delay. In this instant case, the requested EOT period is beyond 1 year. Hence, the Policy guidelines do not cover beyond the one-time extension of one-year period i.e. beyond 08.03.2020. However, the Retail Outlet agency i.e. M/s IOCL has requested to issue the extension of time upto 30.09.2020 i.e more than 12 months delayed beyond 08.03.2020.

As such, issue of extension beyond already granted "In-principle" approval for access permission for proposed retail outlet of M/s IOCL on LHS at Km.223.375 to Km.223.420 of NH-74 (New NH-09) in Village Chutki, Tehsil-Kichcha, District-Udham Singh Nagar in State of Uttarakhand, upto 30.09.2020 will tantamount to relaxation. As per the guidelines, issued by the Ministry vide F. No. RW/NH-33023/19/99-DO-III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments and the comments will be invited within 60 days for the date of uploading in the format enclosed herewith as Form 'A'.
