Sub: NHAI, PIU – Viluppuram – (N/04022/03001/TN) - Proposal seeking NOC & Permission for laying of underground sewerage pipeline from Km.121/250 to Km.121/690 (LHS), from Km.122/060 to Km.122/800 (LHS) and Km.123/000 to Km.123/150 (LHS) with Manhole (2mx2m) at 30m spacing and crossing at Km.123/380 for dedicated sewerage scheme to Tindivanam Municipality of NH-45 (Tindivanam to Ulundurpet section) in the state of Tamilnadu – reg.

- 1) The subject proposal is requesting permission for laying of underground sewerage pipeline 400mm Dia MS Casting pipe is to be laid along the NH-45 from Km.121/250 to Km.121/690 (LHS), from Km.122/060 to Km.122/800 (LHS) and from Km.123/000 to Km.123/150 (LHS) with Manhole (2mx2m) @ 30m spacing, for carrying the Sewerage pipeline with a depth of 1.20m below top of the Subgrade level of service road by Open trench method and crossing at Km.123/380 by HDD method.
- 2) M/s. TWAD Board, RWS Division, Viluppuram has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, If NHAI considers, if necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as when asked by NHAI.


