1	The NH chainage from which pipe line is proposed to be laid is not indicated in the proposal / drawing. This needs to be mentioned in all the documents including license agreement. The checklist also needs to be correct accordingly.	Noted sir, same is mentioned in the enclosed single line diagram and same is mentioned in the all relevant documents, the check list also corrected.
2	Enlarged drawing clearly showing NH chainage, ROW, type of carriageway along with width, pipeline being laid, duly certified by the Executive Engineer, NH Division, Vijayapur needs to be submitted.	Enlarged A3 size drawing is enclosed indicated the ROW and pipe line being laid is marked.
3	Further, checklist needs to be verified and corrected as per site condition and proposal submitted. All the pages of the checklist needs to be verified and certified by the Executive Engineer, NH Division, Vijayapura.	The checklist verified and certified.
4	As per the drawing enclosed with the proposal, it is observed that, the proposed pipeline is crossing the NH at angle. The utility services shall cross the National Highway preferably on a line normal to it or as nearly so as practicable.	As per the enclosure copy.
5	The methodology of laying of pipeline along and across the National Highway is not specified.	Open trench Methodology cross section enclosed.
6	The license fee calculation & performance bank guarantee calculation as per Ministry's circular dtd: 22.11.2016 needs to be submitted. Supporting documents in respect of area rate issued by the competent authority need also to be submitted.	Verified.

7	Proposal in two sets (original) including License Agreement in original (two sets) as per the Ministry's format issued vide letter 22.11.2016 needs to be submitted along with the proposal. The agreement is to be made between "The Chief Engineer – Regional Officer, MORT&H, Bangalore" (Authority) and the Executive Engineer, Minor Irrigation and Ground Water Development Department, Division, Belagavi leaving date/month/year blank. The agreement shall be a true copy of the Ministry's format issued vide letter dated 22.11.2016 without any typographical errors along with witnesses signature. Further, the chainage along with the side RHS/LHS (w.r.t increasing chainage of NH) as per the drawing enclosed with the proposal may be mentioned in the License agreement. 


