#### Invitation of Public Comments

Subject: Issue of NH Access Permission for New MS/HSD retail outlet abutting on LHS boundary of NH -234 (Mangalore - Thiruvannamalai section) at Km 44.505 in Sy. No. 233/3B of Malady village, Belthangady Hobli, Belthangady Taluk, Dakshina Kannada District, Karnataka State-Reg.

The proposal seeking access permission to the above retail outlet of M/s. HPCL was submitted by M/s. HPCL vide letter dated 09.12.2015 (Annexure -I). The proposal is verified/certified by Executive Engineer, NH Division, Mangalore vide letter dated 09.12.2015 (Annexure - II). The proposal was examined and provisional approval was accorded vide this office letter of even no. dated 29.01.2016, as the oil company proposed 5.50m service road for a length of 433m plus the A/D lane so that the minimum distance criteria of the cross road intersection existing in front of the proposed site is met (Annexure - III).

2. Now, M/s. HPCL vide letters dated 20.12.2017 & dated 23.04.2018(Annexure - IV), has submitted modified proposal without service road as proposed earlier, seeking relaxation to the minimum distance criteria enclosing therewith certificate from the local authority. The Executive Engineer, NH Division, Mangalore vide letter dated 20.03.2018 (Annexure - V) has stated that the opposite cross road is dead end road for a length of 400m leading to dwelling houses, which does not carry any movement of HCV/LCV and used mainly by two wheelers/cars with minimum traffic movement and has verified/certified the proposal. As per the Ministry's guidelines dated 24.07.2013, the minimum distance from intersection with rural roads/approach roads to private and public properties is 300m for rural area category. Hence, the proposal necessitates relaxation to the Ministry's norms.

3. As per the guidelines issued by the Ministry vide OM No.RW/NH-33023/19/99-DO-III dated 16.03.2016 (Annexure - VI), the relaxation application will be made available for public comments and the comments will be invited within 60 days from the day of uploading as per the Format enclosed as Form- A.

4. In view of the above, comments of the public on the above relaxation proposal is invited to the below mentioned address:

With reference to the above subject proposal after we have submitted the certified proposal from the Field Authority vide the Ref.2, and subsequently we have received letter from your esteemed office vide ref.1 to comply the certain observations, so we hereby submit the compliance as below;

2	It is mentioned in the para 1.1.1(ii) of checklist that the distance of intersection with rural roads/approach roads to private and public properties is at a distance of 5m on the opposite side from the proposed retail outlet whereas the same is shown at a distance of 50Mt from the retail outlet in the 1.5Km radius layout plan. The discrepancy needs to reconciled and the corrections may be made accordingly It is observed from the layout plan that, it is proposed to	Noted and corrected checklist is been enclosed
2	construct a divided carriageway (5.5m carriageway on either side along with 0.3m width median) from Km44.152 to Km44.805 in order to meet the minimum distance criteria of 300m. In this regard, it is felt that the option of construction of the service road may be explored or otherwise the proposal may be forwarded with proper justification for relaxation to this office, so that the same may be forwarded to Ministry for consideration under relaxation.,	As per your opinion we hereby propose the service road from KM44.150 to KM44.763 so that the access to the proposed retail outlet is from the service road only and not from main carriageway and also the distance between the opposite cross road to the access point of the retail outlet meets the MoRT&H Norms.

Since as we are proposing the service road in front of the retail outlet due to technical and economical reasons due to the earth filling requirement we hereby shift the above site towards the Mangalore side by 23Mts as we have the frontage of more than 100Mts under the same Sy Number and accordingly we have amended the proposal in all respects and also the certified proposal from the PWD field Authority is been enclosed.

Please do the needful for the issue of NH access permission.

Since as per the approval due to existence of opposite side private road to houses we have proposed to construct 5.5mt wide service road for a length of nearly 433Mts plus the A/D lane such that the minimum distance clause of the cross road intersection existing in front of the above proposed site meets the NH Norms.

Subsequently we have checked the traffic count on the opposite cross road and found that the traffic is very minimal of 2 wheelers only for the houses, which we are supposed to foresee before we have submitted in the earlier proposal which was not done due to oversight, so for the same we regret. The existing cross road on the opposite side carries the very minimal of vehicles for the houses only i.e. 5-6 Cars and 12-15 two wheelers do not carry the HCV & LCV movements traffic and the same the certificate from the local competent Authority is been enclosed for justification.

Sub: Guidelines/norms for access permission to Fuel Stations, Private Properties, Rest Area Complexes and such other facilities along National Highways- reg.

The power to give for access to National Highways lies with the Highway Administration as per the Highway Administration Rule. 2004 under the control of National Highways (Land and Traffic) Act. 2002. While exercising this power, the Ministry issued the general guidelines/norms for access permission to fuel stations, private properties, rest area complexes and other facilities vide Ministry's Circular No. RW/NH-33023/19/99-DO-III dated 24.7.2013. The norms and guidelines were issued as per enclosures of the Circular at Appendix-1 (along with Annex-I. II & III to Appendix-1) and Appendix-II (along with Annex-I. II and III to Appendix-II).

2. The Ministry has been receiving many cases of relaxation from the Ministry's norms stipulated in the Circular under reference. It has been observed that many cases of deviations from the extant guidelines, specifically distance from intersection, gap in central median, distance from nearest fuel station, distance from toll plaza and non-fulfillment of the criteria of construction within a year of issuing NOC have been received for relaxation by the Ministry.

3. In view of the above, it has been decided that the application for relaxation in the guidelines/norms for access permission to fuel stations, private properties, rest area complexes and other such facilities along National Highway will be filled up by the applicants through online forms and will be submitted to the concerned Highway Administrator. Before the issue of provisional NOC and in principle approval, the Highway Administrator will make available in the Ministry's website (morth.nic.in) the complete application for public comments, thereby bringing out the relaxation sought by the applicant. Comments will be invited within 60 days

from day of uploading and will be in the format as enclosed as Form-A. The Highway Administrator will subsequently take the decision on the application in a speaking order for accepting or rejecting the relaxation sought and taking into consideration the objections received on the matter. The applicant may have a further period of 30 days for appealing against the Highway Administrator to the Appellate Authority who will be the Chief Engincer of the respective Project Zone in Ministry of Road Transport & Highways. Chief Engineers will take into consideration the application of the applicant seeking relaxation. the objections received from the general public and the speaking order of Highway Administrator to decide on the appeal. The order of the Appellate Authority shall be final.

The Highway Administrator will issue the 'in principle' approval and the Provisional NOC for the applications, where relaxation of norms has been sought, only after the completion of the process illustrated in the preceding paragraph.

5. This circular will be read in continuation with circular of Ministry dated24.7.2013 mentioned in first paragraph. The other provisions of the earlier circular will remain applicable.

6. The competent authority in the Ministry shall notify the Appellate Authorities for their respective Highways Administration. The contents of this Circular may be brought to the notice

of all the concerned in your organization. 7.
