Invitation of public comments

Subject:- Permission for access and approval to proposed Retail outlet of oil company (IOCL) abutting on NH-27 at chainage Km 223/430 (between chainage Km 223/405 to Km 223/455), Survey No.107/P1/P1 right hand side at village Makansar, Taluka Morbi District Morbi in the state of Gujarat.

The instant proposal was granted provisional NOC vide this office letter of even number dated 18.09.2015 which was further extended upto 18.09.2017.

2. The proposal for final access permission dated 14.09.2017 was forwarded to Project Director, PIU- Rajkot vide letter dated 15.01.2017 for his examination and submission of completion certificate. Accordingly, PD Rajkot vide letter No. NHAI/PIU/RJK/2018/D-369 dated 07.02.2018 submitted final completion certificate. Mean while the period of two years from issue of provisional NOC was also completed and as per Ministry's guidelines No.RW/NH-33023/19/99/DO-III dated 24.07.2013 and its amendment dated 01.12.2014 the validity of provisional NOC was expired.

3. It is noted from the submission of oil company which was forwarded by PD- Rajkot that there was delay of 5 months for seeking permission from GSPC to set up CNG facility based on local customer demand and representation. Further, there was delay of 1year and 1 month for obtaining revised NOC with CNG facility from Collector Morbi.

4. For instant case the validity of provisional NOC was expired on 18.09.2017 for which the oil company vide letter dated 25.09.2018 requested to consider the case as per provision mentioned in para.2 & 3 of guidelines No-RW/NH-33023/19/99-DO-III dated 16.03.2016. (guideline for relaxation for access permission proposal).

In view of the above, comments of public for relaxation against time deviation for 5. granting final NOC beyond 2 years after issue of provisional NOC, if any, on the above mentioned proposal is invited on below mentioned address/ Email address.
