Invitation of public comments

Sub: Proposal for grant of access Permission to an Existing retail outlet of M/s Reliance Industrial Ltd. at Chainage (Old 06/098 to 06/147) and (New 5/953 to 6/004) on NH-15 (Bikaner-Jaisalmer Road) RHS at (plot No. 2 & 3 of khasra No. 3) at village-Nathusar, Tehsil-Bikaner, District-Bikaner in the state of Rajasthan.

M/s Reliance Industrial Ltd ie. The applicant vide letter no. RIL/Bikaner/dated 20.08.2019 has submitted a proposal to this office on above mentioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013 as in 2006, National Highway-15 at said location was 2 lane (under jurisdiction of PWD NH Division Bikaner) and there was no intersection with any category of road from fuel station within 100m and proposal satisfied all Norms of Ministry guideline dated 17.10.2003 and, therefore, Ministry granted Final NOC to fuel station vide letter dated 09.10.2006. This Agreement/NOC/License Deed is valid for 15 years from the date of issuance of NOC by the Ministry. The Oil Company could not energize the fuel station on time Due to crude pricing issue and certain unavoidable circumstances but now company want to energize the fuel station but proposal not follow the norms of Ministry Guideline dated 24.07.2013 because there exists intersection of NH with a road at a distance of 60m from the proposed retail outlet as against minimum stipulated distance of 100m as per Ministry's Guidelines, thus violating the Ministry Guidelines. However the Authority has proposed to Constructed 7 m wide service road in the City.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in)

4.0 This is issued with the approval of Highway Administration-cum Regional Officer, MoRTH, Jaipur.
