Subject: Permission for laying underground water pipeline along the National Highways from Km 610/450 to 613/050 ,Km 613/100 to 622/400,Km 627/000 to Km 629/800(LHS)and 610/530 to 615/250, Km 618/300 to 622/140(RHS) and across the Road Km 611/180, Km 611/900, Km 613/050, Km 613/080, Km 618/900, Km 619/220, Km 619/580, Km 619/740, Km 619/970, Km 620/050, Km 620/310, Km 620/660 and Km 621/750 at boundary of NH-47 for CWSS to Eraniel Town Panchayath and 319 Rural Habitations & Improvements to Padmanabapuram and Kattathurai CWSS in Kanniyakumari District the State of Tamil Nadu - Regarding.

The proposal is regarding permission for laying underground water pipeline along the National Highways from Km 610/450 to 613/050 ,Km 613/100 to 622/400,Km 627/000 to Km 629/800(LHS) and 610/530 to 615/250, Km 618/300 to 622/140(RHS) and across the Road Km 611/180, Km 611/900, Km 613/050, Km 613/080, Km 618/900, Km 619/220, Km 619/580, Km 619/740, Km 619/970, Km 620/050, Km 620/310, Km 620/660 and Km 621/750 at boundary of NH-47 for CWSS to Eraniel Town Panchayath and 319 Rural Habitations & Improvements to Padmanabapuram and Kattathurai CWSS in Kanniyakumari District the State of Tamil Nadu was submitted to this office by the SE, NH, Tirunelveli vide letter No.1032/2019/JDO/dated 22.11.2019. The proposal was earlier examined in this office and the same was returned with certain observations vide this office letter dated 10.12.2019. In response, SE,NH,Tirunelveli to resubmit the proposal to this office in accordance to Ministry's latest guidelines dated 22.11.2016. Accordingly the proposal has been resubmitted by SE, NH,Tirunelveli vide letter No.1032/2018/JDO/dated 31.12.2019.

2. The alignment proposed by the Executive Engineer, TWAD Board, Project Division, Nagercoil is to lay the underground water pipeline along the National Highways from Km 610/450 to 613/050 ,Km 613/100 to 622/400,Km 627/000 to Km 629/800(LHS)and 610/530 to 615/250, Km 618/300 to 622/140(RHS) and across the Road Km 611/180, Km 611/900, Km 613/050, Km 613/080, Km 618/900, Km 619/220, Km 619/580, Km 619/740, Km 619/970, Km 620/050, Km 620/310, Km 620/660 and Km 621/750 at boundary of NH-47 for CWSS to Eraniel Town Panchayath and 319 Rural Habitations & Improvements to Padmanabapuram and Kattathurai CWSS in Kanniyakumari District the State of Tamil Nadu i.e. in a length of 23260m as detailed under:

- 3. The right of way is 9.40m to 21.20m in the aforesaid stretch. The carriageway width of aforesaid stretch is 7.10 to 14.70m. The Executive Engineer, TWAD Board. Project division, Nagercoil has proposed to lay the underground water pipeline at the edge of the ROW for the length of 23260m. However, in the entire length of 23260m the underground pipeline is proposed to be laid at a distance less than 15m from the centre line of the carriageway which is not in conformity with Ministry's guidelines vide letter No.NHIII/P/66/76 dated 19.11.1976. Further by the Executive Engineer, TWAD Board, Project Division, Nagercoil has mentioned that the underground new water pipeline is proposed to lay by using *Trench method* where the distance is less than 15m from the center line of the carriageway and crossing at the Km 611/180, Km 611/900, Km 613/050, Km 613/080, Km 618/900, Km 619/220, Km 619/580, Km 619/740, Km 619/970, Km 620/050, Km 620/310, Km 620/660 and Km 621/750 by using in *Trenchless method*.
- 4. The Executive Engineer, TWAD Board, Project division, Nagercoil underground new water pipeline has furnished an undertaking to the effect that TWAD will remove the laid underground water supply pipeline line in future if required by NH wing of State Highways Department/ MoRTH Govt. of India at any time for expansion of the NH at their own cost

without claiming any compensation from NH wing of Tamil Nadu/MoRTH Govt. of India and any right on the NH land. Further, mentioned that TWAD will also restore the surfaces to its original condition soon after removal of the underground water supply pipeline. Also, certificated that the proposed underground water supply pipeline work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

5. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading.
