Sub: NHAI, PIU – Viluppuram – Proposal seeking NOC and Permission for laying of Sewerage Pipeline across the road at Km.164/000 of NH-45 at Ellis Chathiram Junction (Tindivanam to Ulundurpet section) in Viluppuram District in the state of Tamilnadu – by the Executive Engineer, TWAD Board RWS Division, Viluppuram – Approval Requested – reg.

- The subject proposal is requesting a permission to lay an underground sewerage pipeline 400mm Dia MS Casting pipe is to be laid across the road at Km.164/000 of NH-45 at Ellis Chathiram Junction for carrying the sewerage pipeline with a depth of 4.20m below top of the Subgrade level (2m from OGL) by HDD method in the project stretch of Tindivanam to Ulundurpet section of NH-45 in the state of Tamilnadu.
- 2) M/s. TWAD Board RWS Division, Viluppuram had given an undertaking to shift the utility line for any work of improvement or repairs to the road, If NHAI considers it as necessary, in the future, it will be carried out as desired by the NHAI at the cost of the applicant within a reasonable time (not exceeding 60 days) of the intimation given. Further, the applicant has furnished the undertaking to pay rent/fee as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R Dt.22.11.2016 as and when asked by NHAI.
- As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) Dt.22.11.2016, the proposal submitted by M/s. TWAD Board RWS Division, Viluppuram will be put out in the Ministry's website for 30 days seeking Claims/Comments/ Objections (on ground of public inconvenience, safety, and general public interest) from the day of disclosure in the website.
