Subject:- Permission proposal for laying 22KV underground Cable line road cross by trenchless method at Km 104/030 of NH-532 (Cuddlaore-Vridhachalam-Salem road) in Bethasamuthiram Village Chinna Salem Taluk, Kallakurichi district in the state of Tamil Nadu- -Reg.

The proposal is regarding request for permission for laying 22KV underground Cable line road cross by trenchless method at Km 104/030 of NH-532 (Cuddlaore-Vridhachalam-Salem road) in Bethasamuthiram Village Chinna Salem Taluk, Kallakurichi district in the state of Tamil Nadu by M/s NIRT Renewable Energy Pvt Ltd., Salem submitted to this office by the SE (NH), Chennai vide letter No. 607/2023/AE-I/NH dated 06.03.2023. The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying underground cable line is 43.70m. The carriageway width of stretch at Km 104/030 of NH-532 is 7.00m. M/s NIRT Renewable Energy Pvt Ltd., Salem has proposed to laying 22 KV underground Cable line road cross by trenchless method at Km 104/030 for a length of 43.70m by adopting trenchless method across the National Highway.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
