Sub: NHAI - Madurai Region - PIU-Tuticorin - Madurai - Aruppukottai section of NH 45B - Proposal for Erection of 230 KV Overhead Transmission line crossing at km 248+ 400 Proposal submitted by Superintending Engineer ,TANTRANSCO , GCC Madurai- In-Principle Approval Requested - Public Comments Invited - Reg.

The proposal received from PD, PIU-Tuticorin vide letter NHAI/PIU/TUTY/NH-45B/2022/745 dated 22.06.2022 thereby requesting Permission for Erection of 230KV and 110KV DC Tower line Crossing at Km.248+400 in Madurai - Aruppukottai section of NH 45B in the State of Tamil Nadu proposed by Superintending Engineer ,TANTRANSCO , GCC Madurai.

2) The alignment proposed by Superintending Engineer ,TANTRANSCO , GCC Madurai requesting Permission for Erection of 230KV Tower line Crossing at Km.248+400 in Madurai - Aruppukottai section of NH 45B in the State of Tamil Nadu as detailed under;

- 3) As mentioned in the PD letter, the ROW is 60 m at Km 248/400. As observed from the drawing, the Overhead tower are to be erected across NH at Km 248+400 to 248+430.
- 4) In this instant proposal, the as certified by PD, Tuticorin Vertical Clearance for the proposed erection overhead electrical 230KV overhead Transmission line is 18.26 m.
- 5) Superintending Engineer ,TANTRANSCO , GCC Madurai has furnished necessary undertaking to the effect that they will relocate the Over Head Transmission line and when requested by the NHAI at their own cost. It is also mentioned that, the proposed erection work of 230KV Over Head Transmission line across NH will not cause damage to any other utility, if damaged they will pay the

losses either to NHAI or to the concerned agency as per Ministry Guidelines dated 22.11.2016.
