The proposal received from PD, PIU-Tuticorin vide letter NHAI/PIU/TUTY/NH-7A/2022/888 dated 20.07.2022 thereby requesting Permission for Erection of 110KV SC Overhead transmission line Crossing at Km.36+200 in Tuticorin - Tirunelveli section of NH 7A in the State of Tamil Nadu proposed by by Superintending Engineer, TANTRANSCO, Tirunelveli.

2) The alignment proposed by Executive Engineer, TANTRANSCO, Tirunelveli. requesting Permission for Erection of 110KV SC overhead transmission line Crossing at Km.36+200 in Tuticorin - Tirunelveli section of NH 7A in the State of Tamil Nadu as detailed under;

- 3) As mentioned in the PD letter, the ROW is 45 m at Km 36+200. As mentioned in the proposal, the Overhead tower are to be erected across NH at Km 36+200 to Km 36+000.
- 4) In this instant proposal, the as certified by PD, Tuticorin Vertical Clearance for the proposed erection overhead electrical 110KV overhead Transmission line is 14.25 m.
- 5) Superintending Engineer, TANTRANSCO, Tirunelveli has furnished necessary undertaking to the effect that they will relocate the Over Head Transmission line as and when requested by the NHAI at their own cost. It is also mentioned that, the proposed erection work of 110KV Over Head Transmission line across NH will not cause damage to any other utility, if damaged they will pay the losses either to NHAI or to the concerned agency as per Ministry Guidelines dated 22.11.2016.
