Subject:- Permission proposal for laying TWAD Board-Augmentation of Water supply Scheme to 708 habitations in Annur, Avinashi and Sullur Unions in Coimbatore and Tiruppur Districts-laying underground water supply pipe along the road 250mm dia DI water pipe line from Km 4/175 to 5/345(RHS) & road crossing at Km 4/175 of NH-381(Avinashi-Tiruppur-Avinashipalayam road) in Tiruppur district in the state of Tamil Nadu-Reg.

The proposal is regarding request for permission for laying underground water supply pipe along the road 250mm dia DI water pipe line from Km 4/175 to 5/345(RHS) & road crossing at Km 4/175 of NH-381(Avinashi-Tiruppur-Avinashipalayam road) in Tiruppur district in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Major Project Division, Saibaba Colony, Coimbatore submitted to this office by the SE (NH), Salem vide letter No.1039 /2022/JDO/NH dated 22.04.2022(received on 27.04.2022). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is varying from 25.20m to 41.60m. The carriageway width of stretch from Km 4/175 to 5/345(RHS) of NH-381 is 16.00m. The Executive Engineer, TWAD Board, Major Project Division, Coimbatore has proposed to lay the underground Public Utility at edge of the ROW for a length of 1170m by adopting open trench method along the National Highway and HDD method across at Km 4/175 the National Highway.


3. The Executive Engineer, TWAD Board, Major Project Division, Coimbatore has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Major Project Division, Coimbatore will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
