Invitation of public comments

Sub: Proposal for grant of access permission to a new retail outlet of M/s HPCL at Ch.15/031.774 to Ch.15/052.50 (RHS, Plot No. 03 & 04) on NH-162A at Village-Sanwar(Fatehnagar), Tehsil- Mavli & District-Udaipur in the State of Rajasthan.

M/s HPCL ie. the applicant vide letter No.UDRO/AK/FATEHNAGAR dated 13.01.2020 has submitted a proposal to this office on above captioned subject. The applicant has sought relaxation from Ministry Guidelines issued vide letter No. RW/ NH-33023/19/99-DO.III dated 24.07.2013. The proposal was forwarded to EE PWD NH Div-Udaipur vide this office letter 16.01.2019 for comments and factual report. EE PWD NH Div-Udaipur vide letter No.EE/NH/Udaipur/1234 dated 05.02.2020 has submitted the required report mentioning that there exists a intersection with any category of road of carriageway width of 3.5m and above at 275 against 300m and intersection with roads of carriageway width of less than 3.5m at 25.30m against 100m as per MoRTH guidelines. However the proposed retail outlet proposal is submitted in this office with a provision to construct service of 5.50m wide and 90.73 m long as per the proposed drawing, which will be constructed and maintained by oil company at their own cost and undertaking for the same is appended with the proposal. Therefore this proposal may be considered through the extant policy of MoRTH and accordingly Public comments (if any) are invited.

2.0 As per Ministry vide OM No. RW/ NH/33023/19/99-DO III dated 16.03.2016, the Highway Administrator will make available the relaxation proposal of Oil company for public comments, and the comments will be invited within 60 days from the day of uploading.

3.0 In view of the above the comments from public on above mentioned proposal is invited on public portal for access permission to fuel station on website of Ministry and Road Transport and Highways (www.morth.nic.in) or as per Form A (copy enclosed) on below mentioned address.
