**Subject: - Engagement of Technical Consultant to provide technical support/advice to Road Asset management System (RAMS) Cell of Ministry of Road Transport and Highways**

The Ministry of Road Transport & Highways proposes to engage **Technical Consultants (1 in Field of Civil Engineering i.e. Highway Engineer)** for a period of 2 years as detailed below:-

**Consultant in Field of Civil Engineering**

- A Qualification:** Graduate in Civil Engineering.
- B Essential Experience:**
- i. **Minimum 6 years** of experience in field of Highway/Bridge Engineering.
  - ii. Exposure to Road Asset Management/Bridge Management System
  - iii. Good Knowledge of IRC Codes/Standard and Specification of Bridge/Highway
- C Desirable:**
- i. Experience in Road Asset Management/ Bridge Management System handling with State or Central Government/ PSU/ Autonomous bodies.
  - ii. Post Graduation/Ph. D.
  - iii. Good Professional Track Record
  - iv. Strong Communication Skills both oral & written.
- D Role and Responsibility**
- i. Coordination with State/ UTs and regional offices / DXC Technology/ Centralized RAMS cell of NHAI
  - ii. Compliance check for uploading of NSV survey data by the regional offices on online centralized RAMS portal.
  - iii. Manage, and analyse road data for road planning and programming purposes
  - iv. Assistance in Analyse and select the road sections that are end of their lifetime
  - v. Assistance in Analyse road sections that suffer from inadequate daily maintenance
  - vi. Assistance in Annual monitoring of performance of road network
  - vii. Assistance in identifying the stretches with appropriate maintenance measure
  - viii. Perform the function as assigned by Ministry
- 2 Period of engagement:** - The initial period of engagement of Consultant(s) would be for a period of maximum 2 (two) years. After expiry of the initial term, engagement may be extended,

based on requirement of Ministry and performance of Consultant(s) concerned, with the approval of competent authority, for a maximum period of two year beyond 2 years.

**3 AGE LIMIT:-**The maximum age limit for Consultant shall be 65 years as on 01-04-2021.

**4. SELECTION PROCEDURE:**

All the applications received in response to the advertisements will be scrutinized and short-listed. Thereafter, shortlisted applicants will be selected by a Screening-cum-Selection Committee by taking an interview.

**5. Remuneration and allowances:**

**5.1. Emoluments:** The maximum amount of monthly consolidated remuneration payable to the Consultants shall be Rs as follow. Fee/Remuneration of consultant(s) will increase by 5% per annum.

Technical Consultant in field of Civil Engineering : 1,42,500/-

**5.2. Allowances:** The Consultants shall not be entitled at any allowance/benefits such as Dearness Allowance, Transport Facility, Residential Accommodation, Personal Staff, CGHS, and Medical Reimbursement etc. However, Conveyance Allowance shall be paid as per Rs 7,500/ per month.

**5.3. Leave, TA/DA, Tax Deduction at Source (TDS):**

**5.3.1. Leave:-**Consultants shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, a Consultant shall not draw any remuneration in case of his/her absence beyond 8 days in a Year (calculated on a pro-rata basis). Also, un-availed leave in a calendar year cannot be carried forward to next calendar year. The Ministry would be free to terminate the services in case of absence of a Consultant by more than 15 days beyond the entitled leave in a calendar year.

**5.3.2. TA/DA:-**No TA/DA shall be admissible for joining the agreement or on its completion. Foreign travel of Consultant permitted only, in exceptional cases. However, Consultant shall be allowed TA/DA for their travel inside the country in connection with the official work after approval of the Competent Authority.

**5.3.3. Tax Deduction at Source (TDS):-**TDS as admission shall be deducted from the monthly remuneration of Consultants. A TDS certificate shall be issued by the concerned DDO on demand.

**6. Working hours:-**Consultant may follow the normal working hours as prescribed (i.e. from 9:00 AM to 5:30 PM). However, as per exigency, one has to sit late to complete the time-bound work without extra remuneration.

**7. Rights of the Ministry:-**The Ministry reserves the right to cancel advertisement/circular, and not to proceed in the matter for engagement of consultant, at any stage, accept or reject any or all applications, without assigning any reason, whatsoever.

**8. Conflict of interest:**

8.1. The Consultant appointed by Ministry of Road Transport and Highways, shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Nation/ Ministry of RT&H/ Government of India nor will he indulge in any employment activity outside the terms of the contractual assignment.

8.2. The consultant will not be entitled to any benefit/compensation absorption/regularization' of service in this Ministry.

9. **Termination of contract agreement:** This Ministry can terminate the contract agreement, by giving 15 days notice to the Consultant(s). However, in exceptional cases, the Ministry reserves the right to terminate the contract agreement with immediate effect assigning any reason.

10. **Relaxation:** The power to relax any or all of the conditions enumerated above shall vest with the Secretary (RT&H), which should be exercised in exceptional cases of highly specialized requirements. The higher amount of monthly consolidated remuneration payable to Consultants of different levels can also be sanctioned with the approval of Secretary (RT&H) in consultation with IFD.

11. Every person engaged as Consultant will have to submit an undertaking that he accepts the terms and conditions as mentioned in the offer letter.
