Engagement of Consultant for Land Acquisition issues in the O/o Regional office, MoRTH, Ranchi.

Regional Office, Ministry of Road Transport & Highways, Govt. of India, Ranchi has decided to engage consultants to monitor the Land Acquisition (LA) issues on the National Highway Network in the State of Jharkhand under jurisdiction of this office, checking of LA cost estimate and for follow up of various issues involved in LA under NH Act, 1956 and to maintain a record of performance of Competent Authority for Land acquisition and prepare monthly progress report as per Ministry's format. The engagement of consultant will be on short term basis (initially for 1 year) and only retired Revenue Officers or due to retire in one / two months who are well versed with local land policies and NH Act, 1956 are eligible for the post. The requirement of consultant is tabulated below:

The Consultants are not entitled to any other allowance / facilities such as Dearness Allowance, House Rent Allowance, Transport Allowance, LTC, Medical, Govt. Accommodation etc. No TA/DA shall be admissible for joining the assignment as Consultant or on its completion. However, they will be given a fixed amount of Rs. 5,000/- per month towards local travel to CALA offices, site, local villages, etc.

The Consultant should have experience of working in the Revenue/DLAO offices in the State of Jharkhand and dealt with LA in the State of Jharkhand and furnish the LA details sought by Ministry from time to time.

The Ministry shall be free to terminate the services of the Consultant at any point of time without assigning any reason, thereof or in case of his absence by more than 15 (fifteen) days beyond the entitled leave (8 days) in a calendar year. In case, Consultant desires to leave the services after joining, he has to serve a notice period of at least 15 (fifteen) days. During the period of his engagement as Consultant, the retired officer should not take up any other assignment.
