### Invitation of Public Comments



1. M/s Bharat Petroleum Corporation Limited i.e the applicant vide letter dated 03.07.2019 has submitted a proposal to this office on the above mentioned subject. The applicant is requesting relaxation from Ministry's guideline issued vide letter no. RW/NH-33023/19/99-DO.III dated 24.07.2013 as due to a "intersection with Rural Roads/ approach roads to private and public properties" is 243m as against the norm of 300m.


